



MINUTES

Internal Revenue Service Advisory Council Public Meeting

November 17, 2021, 11 a.m. ET

The meeting was opened by Mel Hardy, Director of the IRS Office of National Public Liaison who gave welcoming remarks followed by John Lipold, Designated Federal Officer, Branch Chief, IRS Office of National Public Liaison, who provided housekeeping information regarding the meeting. Mr. Lipold welcomed the public to the Internal Revenue Service Advisory Council's ("IRSAC") November annual public meeting.

Mr. Lipold turned the meeting over to Ben Deneka, Chairman, IRSAC, to provide welcoming remarks. Mr. Deneka also introduced the themes of the IRSAC's 2021 Public Report (the "Report") and thanked all who worked to produce it. Mr. Deneka introduced Carol Lew, Vice Chair, IRSAC, who thanked Mr. Deneka, the IRS, and the IRSAC for their work on the report. Mel Hardy then introduced the Commissioner of Internal Revenue, Charles P. Rettig, who provided welcoming remarks and opening comments. Commissioner Rettig also thanked outgoing IRSAC members for their service.
